

## EVENT REGULATIONS

### I. General Provisions

The event IREB exploRE 2025 – Wrocław, hereinafter referred to as the Event, will take place on May 30, 2025, at Concordia Design, Wrocław, Wyspa Słodowa 7, 50-266 Wrocław.

The organizer of the Event is 21CN Radosław Smilgin, with its registered office in Gdańsk, ul. Nadwiślańska 124A, NIP 5832769297, REGON: 241132628, hereinafter referred to as the Organizer.

### II. Terms of Participation

Registering for the Event is equivalent to accepting these regulations.

The participation fee includes:

Participants are responsible for their own travel, return, and any accommodation costs.

Participation requires electronic registration and payment of the full participation fee to the account number 79 2490 0005 0000 4600 8933 9690 at Alior Bank via bank transfer or online payment within 3 business days from the registration date.

The Organizer is authorized to issue an invoice without the recipient's signature.

If the Event is canceled for reasons attributable to the Organizer, the participant is entitled to a 100% refund of the participation fee.
